The Gerda Henkel Foundation is offering Marie Curie Fellowships in M4HUMAN (Mobility for experienced researchers in historical humanities including Islamic studies). This funding initiative is co-financed by the European Commission under the EU's Seventh Framework Programme for Research. It aims to support outstanding scholars in gaining further experience abroad, providing 24-month research fellowships for senior researchers. The deadline for applications is June 15. III. a/ 4 PhD Studentships and 3 Postdoctoral Research Fellowships at Centre for Medieval Literature, University of Southern Denmark and University of York

The Centre for Medieval Literature (CML) is a centre of excellence funded by the Danish National Research Foundation for six years, with the possibility of an extension to ten years. It is jointly based at the University of Southern Denmark (SDU in Odense) and the University of York (UK).

We will be awarding four fully-funded PhD Studentships and appointing three Postdoctoral Research Fellows to start in September and October 2012. Deadline for applications is 30 April 2012.

The Centre takes an integrated European approach to the study of Medieval Literature and welcomes applications from those working on the literary cultures of medieval Europe, from Scandinavia to the Middle East. PhD and Postdoctoral projects will fall within the three main research areas of CML: linguistic interfaces between secular and/or vernacular languages, fictionality, and canon formation. The work of CML is interdisciplinary in seeking to study texts as embedded within social relationships.

Two PhD Studentships and two Postdoctoral Fellowships will be available at SDU and two PhD studentships and one Postdoctoral Fellowship will be available in York. Applicants may apply to both or one institution.

INTRA-EUROPEAN FELLOWSHIP (IEF)

This action aims at supporting experienced researchers of any nationality at various stages of their career, helping them in acquiring new skills (multi or interdisciplinary) and/or to undertake inter-sectoral experiences within EU member states and associated countries. New element since last year is the Career Restart Panel which may assist researchers to resume a career in research after a break. Proposals are submitted jointly by the host organization and the individual experienced researcher. Research fields are chosen freely by the applicants in a 'bottom-up' manner. Financial support will be provided to the selected proposals, for a period of 12 to 24 months full-time equivalent. Funding is provided for advanced training (including complementary skills) and trans-national mobility, on the basis of the "personal career development plan" established by the experienced researcher with her/his personal supervisor in the host organization.

INTERNATIONAL INCOMING FELLOWSHIP (IIF)

This action aims to attract top-class experienced researchers from third countries (fulfilling the eligibility criteria) to work and undertake research and transfer of knowledge in Europe for 1 to 2 years (incoming phase), with a view to developing mutually-beneficial research co-operation. If before the incoming phase, the experienced researcher has been active in one of the International Cooperation Partner Countries – ICPC (Annex 1 of 2012 Work Programme), a possibility is provided to assist the experienced researcher to return to this country, thus contributing to establish sustainable cooperation between these countries and European research organizations. The duration of the return phase is one year. Research fields are chosen freely by the applicants in a 'bottom-up' manner. Proposals are submitted jointly by the host organization and the individual experienced researcher, within the specified deadlines (if applicable and allowed, with a return host organizations in an ICPC Third Country).

INTERNATIONAL OUTGOING FELLOWSHIP (IOF)

This action aims to reinforce the international dimension of the career of European experienced researchers by giving them the opportunity to be trained and acquire new knowledge in a Third Country high-level research organization. Subsequently, these experienced researchers will return with the acquired knowledge and experience to an organization in a Member State or

Associated Country. Experienced researchers for this action who are nationals of a Member State or Associated Country fulfilling the eligibility criteria can apply. Research fields are chosen freely by the applicants in a 'bottom-up' manner. Proposals are submitted jointly by the return host organization and the individual experienced researcher within the specified deadlines. Financial support will be provided to the selected proposal, for a period of up to 36 months full-time equivalent, including an initial outgoing phase (between 12 and 24 months,) in a third country and a mandatory return phase (12 months) in a European Union Member State or Associated Country.

About the Kenyon Institute

The Kenyon Institute (KI) is the Council for British Research in the Levant's research centre in Jerusalem with its origins dating back to 1919. The KI is a hub for local and international researchers from across the arts, humanities and social sciences. It regularly hosts lectures seminars and conferences and enjoys the affiliation of a number of large-scale research projects. Its facilities include a library, guest rooms for visitors, research space and archaeological equipment for hire.

Qualifications:

Candidates should hold a postgraduate qualification (e.g. an MA, MSc, MPhil) in a humanities or social science field, or have experience and interest in working on and in Israel/Palestine. Strong writing, research, editing and computer skills are essential. The ideal candidate will be a self-starter with strong interpersonal skills who is well organised, attentive to detail, and willing to participate in a variety of tasks as needed. A keen interest in the KI's mission and an awareness of current events in Israel/Palestine are essential. The language used in the KI is English, but research experience or familiarity with Arabic and/or Hebrew would be helpful.

Responsibilities

Internship duties vary but may include the following:

Assist resident researchers, the Director and the Research Scholar, with research activities. Each intern will be given a main task to undertake as a project during their internship. Assist in the organisation and coordination of academic lectures and workshops. Support media outreach and publicity for KI activities, including updating the website. Liaise with partner institutions.

Assist with general office tasks, including managing contacts and mailing lists and supporting the librarian.

Benefits

Internships are unpaid, however you are provided with bed and breakfast within the KI hostel, a late Ottoman villa in East Jerusalem (a few doors from the British Consulate General).
Period of internship

Three months, although the first one (Spring) is offered on a two-month basis only. Applications will be reviewed on a rolling basis. Applications for particular terms are on the following schedule:

Spring 2012 internships (April, May): applications are accepted until 4 March 2012.
Summer 2012 internships (June, July, August): applications are accepted from March 3 until April 2.
Autumn internships (September, October, November): applications are accepted from April 3 until June 2.

Winter internships (December, January, February): applications are accepted June 3 until August 2.

Memorial Travel Grant

Dr. Elka Klein (1965-2005) was passionate about her profession as a historian and a teacher. Her untimely death in the spring of 2005 was a great loss to all who knew her, whether personally or professionally. In her memory, her friends and professional colleagues in the fields of History and Jewish Studies have created a fitting memorial to honor her dedication to and her achievements in her academic life.

A cash grant of \$1500 will be awarded in Dr. Klein's memory to a doctoral candidate preparing to spend a semester or more of the 2012-13 academic year abroad conducting historical research towards his/her dissertation.

The grant recipient will be selected by a panel of scholars based on the relevance and potential contribution of the proposed work to the fields and concerns important to Dr. Klein, such as Sephardic culture, medieval history, gender studies, and Jewish studies.

Applicants for the grant are asked to submit four copies of the following information by April 20, 2012. Alternately, all materials other than the recommendation letter may be submitted by e-mail:
